

**AUGUST 2018 Requirements for collectors and recyclers of empty plastic pesticide containers**

	<b>REQUIREMENTS</b>	<b>VEREISTES</b>
1	Individuals or companies that only collect triple rinsed empty plastic pesticide containers and don't recycle them, need not to be registered as long as they handle only nominally empty containers.	Individue of maatskappye wat slegs drie keer gespoelde leë plastiek plaagdoderhouers insamel maar dit nie verwerk nie, hoef nie geregistreer te wees nie, solank as wat hulle slegs nominale skoon houers hanteer.
1	Plastic recyclers must be registered as such with their provincial environmental regulatory authorities.	Plastiekverwerkers moet as sulks by hulle provinsiale omgewings regulatoriese owerhede geregistreer wees.
2	Plastic collectors and recyclers must have secure premises where the plastic containers are kept but it may not be kept for longer than three months without being processed.	Plastiek versamelaars en -verwerkers moet beveiligde persele hê waar plastiekdromme geberg word en dit mag nie vir langer as drie maande onverwerk op sodanige perseel geberg word nie.
3	Plastic drums must be cleaned thoroughly, and wash water must be kept safely for safe disposal. No wash water may be disposed of in natural water bodies or the urban sewerage system.	Plastiekdromme moet deeglik skoongemaak word en waswater moet veilig geberg word vir veilige wegdoening. Geen waswater mag in natuurlike waterliggame of in die stedelike rioleringsstelsel gestort word nie.
4	Only triple rinsed empty containers may be taken in, collected and transported.	Slegs drie keer gespoelde leë houers mag ingeneem, versamel en vervoer word.
5	No triple rinsed empty containers may be sold or supplied to any other parties as containers for any other use.	Geen drie keer gespoelde leë houers mag aan enige ander party verkoop of verskaf word as houers vir enige ander doeleindes nie.
6	Plastic collectors and recyclers must have at least one contact person available on a landline or cell phone plus an e-mail address where they may be contacted.	Plastiekversamelaars en -verwerkers moet ten minste een kontakpersoon beskikbaar hê wat 'n landlyn of selfoon plus e-posadres het waar hulle gekontak kan word.
7	Plastic collectors and recyclers must have proven track records. References from clients may be valuable when approaching CropLife SA for approval.	Plastiekversamelaars en -verwerkers moet bewese rekords hê. Verwysings van kliënte mag waardevol wees wanneer CropLife SA om goedkeuring genader word.
